# CHILD ABUSE PREVENTION MONTH

National Child Abuse Prevention Month is celebrated annually during April to recognize the need to protect local children from harm and to strengthen families by giving them the tools and resources they need to keep children safe.

To create public awareness throughout



the community, we placed blue pinwheel gardens in front of our headquarters office and at all of our Resource Centers. This year, two of PSF's newest partnering organizations, Auto-Plaza of Gainesville and My HealthCare Federal Credit Union, also placed pinwheels in front of their businesses. As an added incentive, Auto-Plaza of Gainesville is donating a portion of every car sold during April to our local prevention efforts at our three Gainesville Resource Centers.

All of our Resource Centers are also sharing prevention items throughout the month with local patrons. Items include door and cabinet locks, baby sleep sacks, swim safety tools and brochures about ways to keep children safe from common threats. Samantha Tracy, our Senior Community Relations Professional, also participated in several regional events where she shared similar prevention items and information. You can read more about her efforts in the Children's Partnership Council Update in this newsletter.

Community involvement and prevention are the best practices for creating a healthy family environment, and PSF looks forward to continuously working toward providing helpful tools to children and families throughout Child Abuse Prevention Month.

Hilary is not just an art instructor, she is a mentor. She is pushing our kids to go outside of their comfort zones and find their voices through art. I was overcome with

#### GAL VOLUNTEERS NEEDED

Recently, the Guardian ad Litem Program (GALP) received an extensive review by the North Highland Consulting Group. The project was conducted to provide recommendations on how the Guardian ad Litem Program can improve its volunteer recruitment and retention. It was a very thorough process including surveys, interviews with volunteers and staff and an

analysis of data from the program. As a result of the findings and recommendations, some changes are under way.

One of the first steps we have taken is a renewed recruitment and training initiative with the aim of focusing on diversity and an increased understanding of poverty's impact on the children and families we work with each day. In order to accommodate these resource needs, the organizational structure has been realigned. The program has transitioned from four regions down to three.

On a different topic, the GALP has also implemented a statewide initiative to review the dependency cases that have been open for more than 24 months. The focus is to identify any obstacles and search for creative solutions that can bring permanency for these children.

With the attention on Volunteer Appreciation and Child Abuse Prevention Month, Guardian ad Litem is a great example of how we can bring the two together to help better meet the needs of the abused and neglected children in our communities. These are some exciting and active times! I'm honored to continue to work with the greatest child welfare professionals and volunteers. I hear amazing things every day about how children's lives are improved for the better and how they are thriving in safe and loving homes as a result of the work all of you do.

#### THE AMAZING GIVE RECAP

On March 29-30, PSF participated for the second time in the Amazing Give, an annual online giving day sponsored by the Community Foundation of North Central Florida. This 24-hour long opportunity allowed us to share our mission and the critical work we do with our community. Utilizing social media, our staff, board directors and other stakeholders helped us share our message and raise money to support the children in our care.

Across the region, 75 non-profits participated in the 2017 Amazing Give. This event allowed 3,551 donors to give more than \$854,000 to various charitable causes through an online donation platform.

This year, our giving focus was directed toward providing personal items, such as clothing and luggage for children entering care, sustainable living opportunities for youth exiting care into independent living, recruitment of new Partner and Adoptive families and participation in extra-curricular activities for our foster youth. PSF had a total of 40 donors who gave \$2,045 to support these critical needs. We are truly grateful to each donor for the impact they made on local children. Our donors stepped up to be the hope our children need. Thank you!



#### ADVOCACY UPDATE

This Legislative session, my first in the role of Community and Government Relations Manager, is shaping up to be a very exciting one. While the House and Senate continue to struggle to come to an agreement on their budgets, PSF has seen great support of our allocation request to support self-sufficiency programs at our Resource Centers. The allocation made it into the first draft of the House's budget, something that all of our Representatives were very impressed with. While this doesn't mean the allocation will be approved, it does show the support of and belief in our Resource Center Model on the state level.

To begin this session, the Florida Coalition for Children came in with an appropriations request of \$49 million to include support for out-of-home care, case management, prevention programs and a \$10 million risk pool. Although it does not look like we will receive this full amount, the House was supportive of our ask, allocating \$20 million in recurring funds for community-based care. We continue to advocate for this great need as the number of children entering out-of-home care throughout Florida continues to rise.

We also received the incredible news that SB 60, the Keys to Independence Act, passed the House and is currently on its way to the Governor for approval. This bill assists youth with getting a learner's permit or driver's license, a crucial step in their journey toward independence. The program has so far served more than 1,200 youth, and this legislation would serve to make the program permanent and will expand the program to youth whose placements change while enrolled in the program.

Finally, as you can see to the right, our staff, board members and Partner and Adoptive Families once again had a very successful day at the 2017 Children's Day event in Tallahassee. We are grateful to all of our legislators who were able to take the time to hear from our agency's representatives!

# FIVE PROTECTIVE FACTORS SERIES: SOCIAL SUPPORTS

2017 is already promising to be an outstanding year for the Resource Centers, with opportunities for national recognition and a focused effort on engaging local faithbased partners.

As you may be aware, in January 2017 Casey Family

Programs (CFP) released a chronicle highlighting PSF's Resource Center Model from the inception of our first Resource Center, the Library Partnership, in 2009 to the opening of our newest location, the Tri-County Community Resource Center, in 2015. CFP has now begun production of a video and formal report detailing the progress of PSF's three Gainesville Resource Centers and their impact on local communities. The ultimate goal of this project is to promote replication of PSF's model on a state and national level. PSF was one of only two locations selected for this project nation-wide.

Senior Vice President of Clinical and Community Services, Pebbles Edelman, and Director of Resource Centers, Stacy Merritt, were able to present at the Child Welfare League of America's National Conference on March 30 in Washington D.C. The presentation focused on PSF's Resource Center Model and involvement as one of CFP's Communities of Hope sites. Representatives from Brooklyn, New York's Center for Family Life were co-presenters for the workshop titled: Communities of Hope.

On April 19, national speaker, Reverend Dr. Darrell Armstrong came to Gainesville to share about his journey from foster care to pastoral care. He also shared practical tools about how faith-based partners in our community can work to strengthen families through our Resource Center Model. A number of local faith-based leaders participated in this learning collaborative. The Resource Center team hopes this is an impactful first step in their efforts to further engage and recognize our faith-based partners.

In continuation of our series related to the Protective Factors framework, we would like to share more about activities related to Social Supports and how they are used to improve outcomes for families. While these social activities and events are popular among patrons, it is often hard for others (funders, leadership, partner agencies, etc.) to understand how an activity such as an outdoor festival or a community dinner is tied to reducing



the risk of child abuse and neglect. However, these activities allow opportunities for local community members to meet one another in low-stress situations with the goal of creating a natural support system.

In turn, this opens up the possibility of sharing a meal once a week, asking someone for a ride or finding an appropriate babysitter so they can go to a job interview. It also allows opportunities to share about similar struggles and accomplishments – all activities that promote family stability and success.



Some recent examples of activities designed to build social connections include a February 14 "Love Celebration" at the Cone Park Library Resource Center. This event allowed parents and children to participate with various arts and crafts and enjoy a special treat while interacting with others from the community.



The Tri-County Community Resource Center (TCCRC) also hosted two, 6 week sessions of UF IFAS's Cooking Matters, which not only allowed participants to make affordable and healthy meals, but also provided opportunities for meeting and talking with other local community members. TCCRC is also planning their second year birthday celebration which is a community-wide event that will be held on April 22.

Zumba and Yoga are health-minded activities offered at the Library Partnership (LP) that have the added advantage of providing socialization opportunities for parents.

Monthly community dinners are an on-going and well-attended activity at the SWAG Family Resource Center.

The LP's Community Advisory Council is an example of a more formalized forum that allows community members, who all volunteer to participate, to come together and have a voice related to their community's needs.

#### CHILDREN'S PARTNERSHIP COUNCIL UPDATE

PSF's Children's Partnership Councils (CPCs) have been busy celebrating Child Abuse Prevention Month in their respective communities. Each allotted funds to purchase safety items including swaddling sleep sacks, water wings, outlet and door knob covers, car and water thermometers, cabinet locks, first aid kits and door alarms to distribute at local community events to families in need. These events not only allowed us an opportunity to provide these safety items, but to also have critical conversations with families about how to keep their children safe from some common household dangers. On behalf of the CPCs, PSF attended the Bradford County Fair, Children's Day in Lake City sponsored by the Early Learning Coalition of Florida's Gateway, Early Learning Matters' Kids Day

in Live Oak, the Early Childhood Children's Fun Festival in Perry sponsored by Healthy Start Jefferson, Madison and Taylor and the Tri-County Community Resource Center's Second Annual Birthday Bash.

The Baker, Bradford, Union CPC and the Columbia CPC have both allocated funds to purchase Voluntary Pre-Kindergarten (VPK) literacy backpacks through the Early Learning Coalition (ELC) of Florida's Gateway. Both of these CPCs have also provided utility and rent assistance to multiple families who, due to emergency circumstances, were at-risk of having their power cut off or being evicted.

The Suwannee, Lafayette, Hamilton CPC has provided clothing for children and youth identified as homeless and utility assistance through the United Way of the Suwannee Valley for families in need. They along with the Madison Taylor CPC, purchased pack and plays for families lacking safe sleep environments for their infants. The Madison Taylor CPC also allocated funds for car seat vouchers through the Madison County Healthy Start program so that families needing to purchase car seats can do so at a reduced cost.

The Dixie, Gilchrist, Levy CPC purchased additional GED vouchers for minors and adults with children seeking to advance their career goals, diapers to keep on hand at the TCCRC for caregivers and car seat vouchers for families with a need for these items. The vouchers will allow families with limited resources to purchase a car seat from the ELC of the Nature Coast at a reduced cost and have it installed by a licensed car seat technician.

Thanks to the dedicated Council members in each community, children and families across North Central Florida have received crucial assistance during their times of need. We are thankful for their continued collaboration, creative thinking and passion for serving our shared communities.

#### FOSTER AND ADOPTIVE RECRUITMENT

We kicked off this year with speaking engagements at Chiles Elementary and Jonesville Baptist Church. In February, we were part of recruitment efforts at Stomp the Swamp and spoke at Temple Shir Shalom. In March, PSF started connecting with several day cares in Alachua County and sent out a total of 400 flyers about adopting and fostering to these targeted audiences. At the Sidney Lanier Spring Festival, we focused on child-specific recruitment for children currently on our Heart Gallery. Children's Medical Services is also showcasing Anthony, one of our recruit kids, in their lobby. We are also partnering with Congregation B'nai Israel and their day school to join in our upcoming events.

One of the goals for the recruitment team this year was to partner more with the University of Florida. Recently, the foster and adoption recruitment specialists were able to connect with the Family, Youth and Community Sciences (FYCS) department at UF. Our first public speaking engagement was to an introductory class, and the presenters walked the students through the child welfare system. Jason Katz, a Family Care Supervisor with Devereux, was one of the presenters and talked about case management. In addition, the Adoption Recruitment Specialist spoke to the FYCS club about the great need for homes for our youth and ways they can advocate for the children in our care. We are looking forward to more connections at UF in the future.

On April 27, PSF will be hosting our very first Info Night at Jonesville Baptist Church (JBC). We are incredibly grateful for JBC's generosity in opening up their space for us. Throughout the evening, we will have staff presenting, answering questions and highlighting local successes. We also hope to provide similar opportunities in the future throughout our 13 counties. Our

goal with the Info Night is to shed light on our current need and to plant the seed for any families who are considering to foster or adopt. There is no pressure to commit, but families will gain more knowledge on how the system works and the many other ways families can get involved.
