MESSAGE FROM THE CEO



Stephen Pennypacker President/CEO Community Partners and Friends,

This April marks my second anniversary as CEO of Partnership for Strong Families. It is a very different world than what I was used to at the Department of Children and Families, and I am proud of what we are able to accomplish on a local level. Community-based care does work, and I see it daily in our ability to problem-solve and work with our community partners to meet the needs of the most vulnerable children in North Central Florida.

Since returning to work in the community I have spent most of my life in, I have been fortunate to reconnect with colleagues and community leaders who are important partners in our system. I have also met a lot of new faces, including the Partner Families who open their homes to

children entering foster care. These individuals remind me continually that the heart of what we do is not the systemic issues we battle, but it is fighting for the child who is dropped into their lives at their most traumatic moment, for whom we are their best hope for a brighter future.

A newer side of child welfare for me is the work we do to prevent child abuse from ever occurring. With April being recognized as Child Abuse Prevention Month, it is a good time to tout the success of PSF's Resource Center Model, for which we are known on a state and national level. Recent data shows a 44-58% decline in verified child maltreatment in the communities surrounding the three Alachua County centers since we opened the doors to our first one in 2009. These centers have become a beacon in the local community, strengthening families before crises occur so that children never need to enter the formal child welfare system. While PSF operates these centers, they are a true reflection of the benefits of community-based care. Each center has more than 30 community agencies as partners in daily operation and making services available at no cost to patrons.

This spring, join us in both recognizing that child abuse is preventable and honoring those Partner Families who take in children who have lived through that abuse.

SEEKING NOMINATIONS FOR ANNUAL AWARDS

World renowned social worker Brené Brown once said, "It is gratitude that makes us joyful." In that case, Partnership for Strong Families may be the happiest place on earth. Every May, PSF likes to give back to all of the Partner Families throughout our communities to show our gratitude for everything they do. This year is no exception as we are deep in preparations for our Day in the Park, the Partner Family Appreciation Picnic, on Saturday, May 21. One of the most exciting elements of the annual event is the recognition of five Partner Families who have gone above and beyond, as well as one staff member who has displayed exemplary service skills in working with families.

Last year, Family Care Counselor Francisco Garcia was honored with the "Power of You" award that is annually given out to a worker in the local child welfare industry who has gone above and beyond their duties. He recently said that his winning was a very "humbling experience" and stated, "Recognition serves as food for the soul, and for people who do most of their work behind the scenes (especially foster parents), this is a great way to say THANK YOU!"

We are currently accepting nominations for these six awards:

Family Connections Award - This Partner Family assists with maintaining family connections with biological parents, siblings and relatives to assist with reunification.

Supporting Educational Needs Award - This Partner Family attends IEP's, school meetings and encourages the child to excel in their education. This parent is diligent with helping with homework and acts as an advocate for the child.

Normalcy Award - This is a Partner Family who encourages children to participate in after school activities, hobbies and clubs. This is a home where you can't tell which child is the foster child in the home.

Health and Well Being Award - This Partner Family consistently transports the children to medical, dental and therapeutic appointments ensuring their physical and emotional needs are met.

Model Parent Award - This Partner Family co-parents children in their home with the biological family by modeling positive parenting techniques. They may allow the biological parent to come into the home to help with the bedtime routine or participate in Family Team Conferences to assist with reunification.

Power of You Award - This worker (Family Care Counselor, Guardian Ad Litem or Independent Living) exemplifies extraordinary service to our Partner Families by providing information, support and guidance to our partners and the children in their care.

LEGISLATIVE UPDATE

The 2016 Legislative Session has officially ended and with much less of the quibbling between chambers that shut down last year's Session.

Several positive bills impacting our system made it through, in addition to some much-needed funding increases. The communitybased care system was also able to work with legislators to prevent any bills passing that would have been detrimental to the system, and for that partnership we are grateful.

The Child's Best Hope Act was signed into law by the governor on March 23 and goes into effect July 1. The bill was championed by the statewide Guardian ad Litem program and enhances a statute change that came about a few years ago allowing a parent to sign their child over to a private adoption entity instead of the state in advance of a termination of parental rights ruling. The important change allows the judge to determine if allowing the private agency to intervene and assume custody and permanency responsibility for the child is in the child's best interests and to deny it if it is not.

House Bill 657 provides another opportunity to acknowledge the tremendous contribution foster families make to the child welfare system and the community as a whole. The law designates the second week of February as Foster Family Appreciation Week and encourages DCF, local governments and community agencies to highlight the work of these individuals, whom we call Partner Families.

Finally, lawmakers recognized that the child welfare system in Florida remains underfunded, which is more severely realized with the current trend of more children entering the system. Legislators appropriated an additional \$22.9 million to child welfare, with \$12.9 million of that being designated as recurring dollars that will be added to the annual appropriation for community-based care agencies.

CONGRATULATIONS TO OUR NEW PARTNER AND ADOPTIVE FAMILIES

Over the course of the 2016 calendar year 18 different P.R.I.D.E. classes are scheduled in nearly half of the counties Partnership for Strong Families serves. They are offered on weekends, weekdays and even in an accelerated format. There are a total of nine different classes that our new Partner Families attend in order to become licensed. At our most recent Alachua County graduation, 22 individuals graduated P.R.I.D.E. and are in the process of completing the home licensure process to become either a Partner or Adoptive Family. In Columbia County, our trainers recently graduated five new individuals.

TRAVEL

Foster Parent Travel logs are due on a monthly basis. Travel submitted past two months will not be eligible for payment. All travel requires supporting documentation. For more information please contact our Licensing AA at (352) 244-1548.

BLUE FOLDERS

Each child is required to come to your home with a placement letter stating the child is being placed in your care with a blue folder containing the child's legal and medical information. Contact your FCC or Placement Specialist as soon as possible if the child has not arrived with these items.
