Each year, tens of thousands of Florida's children are put into out-of-home care. Partnership for Strong Families (PSF) is committed to protecting these children while preserving their families. Join us in providing supportive, nurturing and protective environments for kids in need.

Established in 2003, PSF is the lead community-based care agency for Florida Judicial Circuits three and eight. PSF is contracted by the Department of Children and Families (DCF) to deliver comprehensive child welfare services to children who are victims of abuse and neglect. PSF also works with at-risk families to prevent child abuse and to decrease the risk of children entering out-of-home care.
