State Employee Benefit

The state employee benefit is not only open to state employees who have recently adopted but is also open to veterans and servicemembers who adopted after July 1, 2020 and law enforcement officers who adopted after July 1, 2022. In July of 2024, the state added healthcare practitioners earning less than \$150,000 per year and tax collector employees as qualifying for the benefit. Open enrollment begins the first business day in January and goes through the last business day in March. If you believe you qualify for the state employee benefit, contact your employers HR department for the state employee benefit form and send the form with sections 1 and 2 completed to Tricia Braitsch (Patricia.Braitsch@pfsf.org). PSF will complete section 3.

DCF COLA Memo for 2026

The DCF Cost of Living Allowance (COLA) memo for 2026 has come out! The COLA memo is in regard to foster care board rates for children currently in foster care. There is mention in the memo that adoptive parents can request the current foster care board rate amount as their child's adoption subsidy amount. The current rate for 0-5 year olds is \$602.75, 6-12 year olds is \$618.19, and ages 13 and up is \$723.58.

If you are interested in receiving the current foster care board rate amount as your child's adoption subsidy amount, please send an email to patricia.braitsch@pfsf.org requesting the COLA rate with your name, mailing address, phone number, and child/children name(s). Per the state, all requests must be in writing and phone call requests will not be accepted.

February is Children's Dental Health Month

Dental coverage is included in your child's Medicaid benefits; however, the dental benefits are not administered by Sunshine Health. Dental plans are administered through private organizations such as DentaQuest or Liberty Dental. It is recommended that your child sees a dentist twice a year for regular cleanings and checkups, as regular visits to a dentist can help keep teeth and gums healthy.
