## State Employee Benefit

The start of the new year brings open enrollment for the state employee benefit for adopting children through the foster care system. The state employee benefit is not only open to state employees who have recently adopted, but is also open to veterans and servicemembers who adopted after July 1, 2020 and law enforcement officers who adopted after July 1, 2022. In addition, in July of 2024 the state added healthcare practitioners who earn less than \$150,000 per year and tax collector employees can qualify for the benefit. Open enrollment begins the first business day in January and goes through the last business day in March. If you believe you qualify for the state employee benefit, contact your employers HR department for the state employee benefit form and send the form with sections 1 and 2 completed to Tricia Braitsch ([Patricia.Braitsch@pfsf.org](mailto:Patricia.Braitsch@pfsf.org)) for completion of section 3.

## DCF COLA Memo for 2026

At this time the new DCF COLA memo for 2026 has not come out, so you cannot make a request for an increase until that time per DCF. We do not know when the memo will come out, nor do we know if adoption subsidy will be included on the memo.

You can Google "DCF Florida COLA memo 2026" to find out if the new memo has come out. ## Sunshine Health Updates

Did you know children who have Sunshine Health Pathways to Shine Specialty Plan are eligible for a Care Grant? The Care Grant is up to \$150 per child per calendar year for services and supplies for social or physical activities, such as gym membership, sports equipment and registration fees, art supplies, and application fees for post high school education.
