#### **MEDICAID UPDATES**

This is a friendly reminder that if there are questions or issues regarding your child's Medicaid, please contact their Medicaid provider regarding the question or issue first. If they are not able to answer the question, fix the issue, or if they say you as the parent are not an authorized caller, please contact Laura Waxman at laura.waxman@pfsf.org or by phone at 352-244-1580. There are glitches that occur within the Medicaid system that we have no control over, but can help fix if we are made aware. PSF does not make unauthorized changes to your child's Medicaid without the parent's consent and knowledge.

Also, if your child has Sunshine Health as their Medicaid plan, the name of the plan is Child Welfare Specialty Plan. This is the plan for foster AND adopted children. We know this is very confusing, but that is the name of the Sunshine plan.

#### ADOPTION FINALIZATIONS

This past fiscal year (July 1, 2021 to June 30, 2022), Partnership for Strong Families finalized the adoptions of more than 170 children!! Congratulations to all the new adoptive families from this year!

#### WELL CHILD CHECKS

Don't forget, make sure your child receives their yearly physical before school starts in August. Even if your child is not school aged, it is important that they receive their scheduled Well Child Checks. Please contact their pediatrician to schedule an appointment.
