SUNSHINE HEALTH CHILD WELFARE SPECIALTY PLAN NEW BENEFITS

Children on Sunshine Health's Child Welfare Specialty Plan have a new benefit: SWIM LESSONS!! The swim lessons are in the form of a voucher for up to \$200 towards swim lessons at the local YMCA. If there isn't a local YMCA, member services will assist in finding another swim provider. All that you need to do to get the voucher is contact Sunshine Health Member Services at 1-866-796-0530. PSF does not provide the vouchers, and will not be able to answer any questions regarding the voucher, as it is a benefit through Sunshine Health. Also, the Envolv App to order over the counter medications is not longer in service. Instead, over the counter medications can now be ordered through CVS. In order to use the \$25 over the counter medication benefit you can request the medications via mail-order, where medications will be delivered to your home at no cost. To request medications via mail-order, please call 1-888-624-1139 and have your child's member ID number ready when calling. Another option is to order over the counter medications directly through CVS in the store. STATE EMPLOYEE BENEFIT FORMS

If you are a state employee who finalized your adoption within the last year, then you might qualify for the state employee benefit for adopting special needs children. The benefit was also recently made available to veterans and law enforcement officers. For state employees, please contact your employer for the form and send it to Tricia Braitsch for completion of section 3. The benefit is awarded on a first come, first serve basis with applications being accepted from the first business day in January until the last business day in March. Due to no fault of their own they have experienced multiple moves over the past year, they need a family that is committed to them long term. It is very true for these four that their sibling bond is strong and impenetrable. They have truly leaned and depended on one another through everything. Placing these siblings together is required due to their bond with each other.
