



BACK TO SCHOOL DRIVE 2022

We have just finished packing nearly 600 backpacks full of school supplies for children in foster care across our 13 counties! This is a large effort that would not be possible without support from our generous donors, our amazing volunteers, and our incredible staff. We would like to extend a huge thank you to the United Way of North Central Florida for allowing us to utilize their space during our drive. This back to school season we received \$7,916 in financial donations, we had 16 donation bin partners, and we had the help of 8 wonderful volunteers. We are especially grateful for the support of our donation drive this year, as it allowed us to provide for so many children and families in our care. While completing our shopping trips for additional supplies, we realized just how much prices have risen this year. Due to these increasing costs, we are incredibly grateful for our ability to alleviate the financial pressures of our caregivers and allow them to focus their energy and time on creating loving homes for the children in their care. It's hard to believe in a few short months we will start planning again for our largest donation drive, Wish Upon a Star! We hope to see you there!



LEGISLATIVE UPDATES

We are in the process of implementing several new legislative initiatives that you will want to know about. Senate Bill 7034, effective July 1, 2022, amended sections 39.5085 and 409.145, Florida Statutes (F.S.) which:

• Revised room and board rates for Level I licensed foster home caregivers.

• Revised out-of-home caregiver populations eligible for the annual cost of living increase each January and the 10 percent life skills supplemental payment.

• Revised relative and non-relative caregiver rates for families in an open dependency case.

• Establishment of a \$200 childcare subsidy payment to non-licensed and licensed foster home caregivers who have a child placed in out-of-home care between the age of birth through 5 years old.

In addition, effective July 1, 2022, s. 1009.25 Florida Statutes (F.S.) expanded the population of students eligible for the tuition and fee waiver to include:

• A child that is, or was at the time of reaching 18 years of age, placed in the custody of a relative or non-relative under s. 39.6221, F.S.

• A child who was reunified with their parents, who spent at least 18 months in out-of-home care after reaching 14 years of age, including reinstatement of parental rights under s. 39.8155, F.S., who are Pell Grant eligible.

We are thankful to the 2022 legislature for allocating substantial new funding to community-based care. Overall, there will be \$150 million new recurring dollars in the system. For PSF, this means an additional \$5.8 million to our core funding. Like many parts of the economy, it has been difficult to attract qualified applicants for open positions and to retain them once they are on board. These funds were awarded to increase salaries for case managers and lead agency staff to increase recruiting and retention.

FAST TRACK TO FOSTER RECAP

Last month, we had the incredible opportunity to train new foster parents in person again! We hosted a 3-day PRIDE training class that was fully supported by Foster Florida, a nonprofit that provides wrap around supports to foster families in our area. They provided meals and childcare throughout the whole training in partnership with Destiny Community Church. We had 39 families in attendance, and we expect about 25 of those families to begin the licensing process right away. We are excited about these new families joining us in their fostering journey!



GRANT UPDATE

We are thrilled to announce we just passed the halfway mark in our five-year Community Collaborations to Strengthen and Preserve Families Grant awarded in October 2019 by the Children's Bureau! Nearly three years ago, we set out with the mission to evaluate, refine, and expand our Resource Center Model.

Evaluation

In March 2021, after the grand opening of our NorthStar Family Resource Center (NSFRC), we started collecting survey data as part of our evaluation. To date, our Community Research Coordinators have enrolled 176 Resource Center patrons in our research study, and follow ups are past the 80 mark! We have engaged the community every step of the way and sought out their voice in a variety of evaluation activities with more planned for the second half of our grant period.

Refinement

Since the grant was awarded, the grant team, RC staff, and PSF's IT department have worked tirelessly to refine our data collection protocols. With the refinement of our data collection, we can report on new, more profound metrics and better understand how our Resource Centers are serving children and families in North Central Florida.


One of the largest refinement efforts to date was the Strengthening Families Self-Assessment (SFSA) process. Each of the three Gainesville Resource Centers completed the SFSA process which engages direct service staff, community collaborators, and community members in equitable evaluation methods to ensure community voice is continuously heard and incorporated.


Based on the discussions from the SFSA process, LP and CPLRC will work to develop Parent and Community Advisory Councils. In addition, our resource centers have already implemented several changes related to inclusion such as increasing the availability of written materials in Spanish and posting LGBTQ+ welcoming signs that let patrons know they are both welcome and safe in our centers.

Expansion

On March 18, 2021, Partnership for Strong Families opened its doors to the Columbia County community at the NorthStar Family Resource Center. Prior to opening, PSF staff, community partners, and community volunteers spent months conducting a community needs assessment to ensure the services and supports offered were what was most needed in the community. As of June 1, 2022, the NSFRC has received 3,315 service requests from 3,090 visitors across our five protective factor categories. We have been able to offer a variety of services and supports like a clothing closet, after school homework help, and job search assistance with the help of community partners. Service requests were mainly related to concrete supports in times of need (43.6%), social connections (39.9%), and enhancing the social and emotional competence of youth (21.7%).

Engaging local teens has been a key focus at the NSFRC. In December 2021, the NSFRC hosted its first "Let's Talk About It!" monthly event, which invites teens and young adults to engage in conversations about their experience in the Lake City community. Growing out of the "Let's Talk About It!" monthly events, a youth council was created to engage and encourage youth to use their voices, develop projects, and obtain leadership skills through problem solving.





THE AMAZING GIVE UPDATE

SWAG FAMILY RESOURCE CENTER CELEBRATES 10 YEARS

SWAG Family Resource Center, the second of five family resource centers operated by Partnership for Strong Families, opened its doors to several southwest Gainesville communities in June 2012. What better way to celebrate this milestone than with a community-wide birthday dinner! The celebration included great food, music, dancing, and sharing memories of SWAG FRC's first 10 years.

During our first decade, SWAG FRC received more than 110,000 visits and 120,000 requests for services, ranging from concrete supports (e.g. food, clothing, baby products) to programs designed to promote parental resilience including employability workshops, health fairs, and financial literacy classes. SWAG FRC is also known for providing quality academic and enrichment programs for local youth, including after school, summer, and Spring Break programs. Children's programs at SWAG FRC receive support from Alachua County CAPP, the SW Advocacy Group, and more.

A special thanks to the SW Advocacy Group who offer ongoing support and guidance for SWAG FRC and helped to make our birthday celebration a success through generous donations and hard work! We also appreciate Christ Community Church who went above and beyond by preparing and serving a celebratory meal for the community members and leaders who attended the event. Like all of our Family Resource Centers, SWAG FRC is a collaborative effort that would not be possible without amazing community partners, volunteers, and donors! Thank you! 
