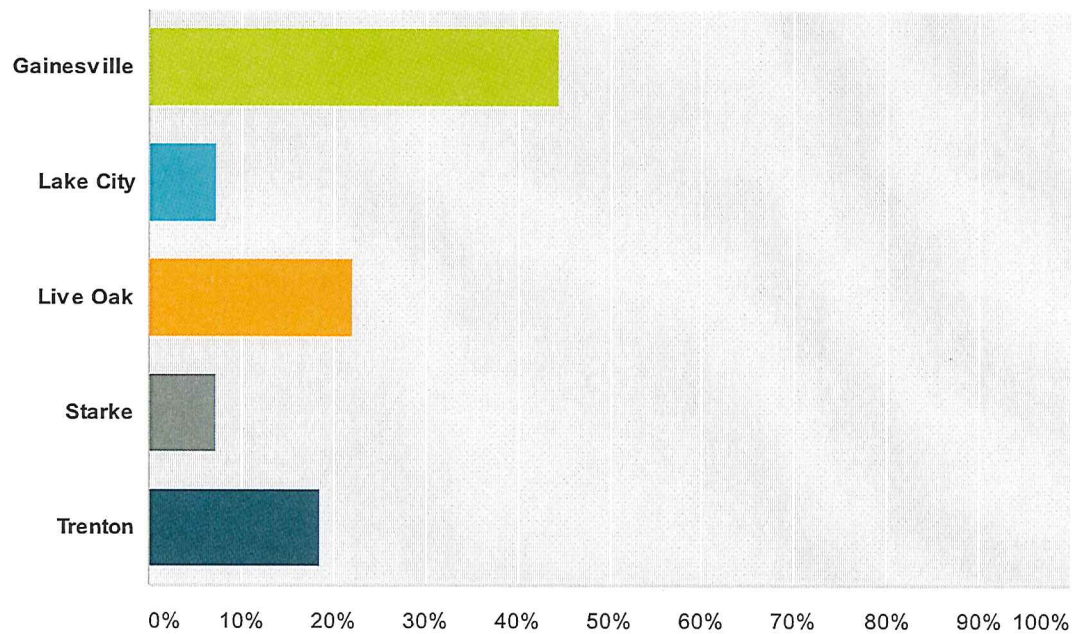

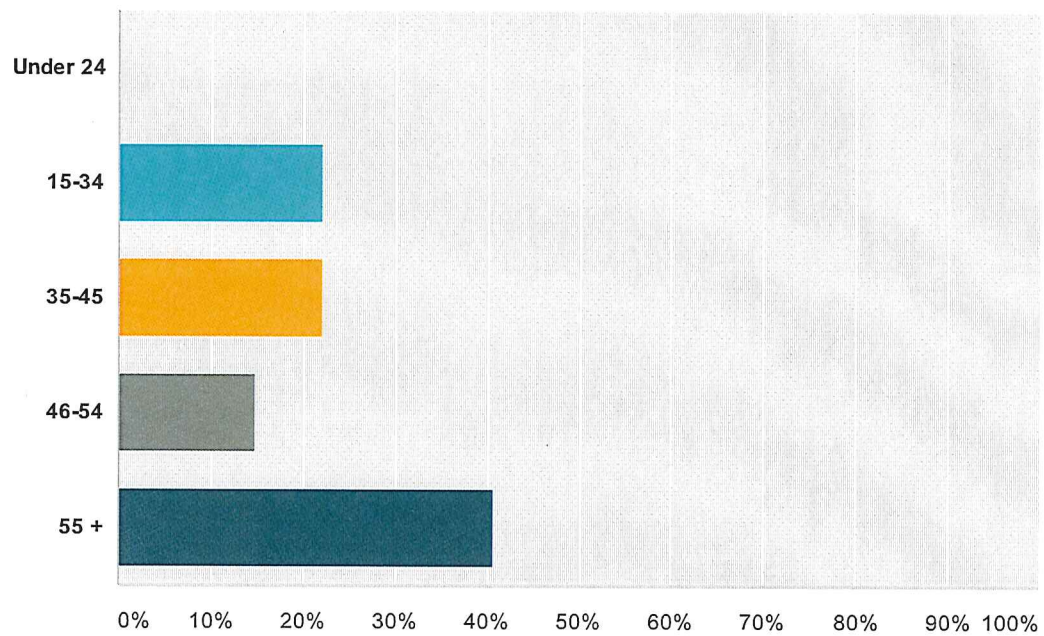

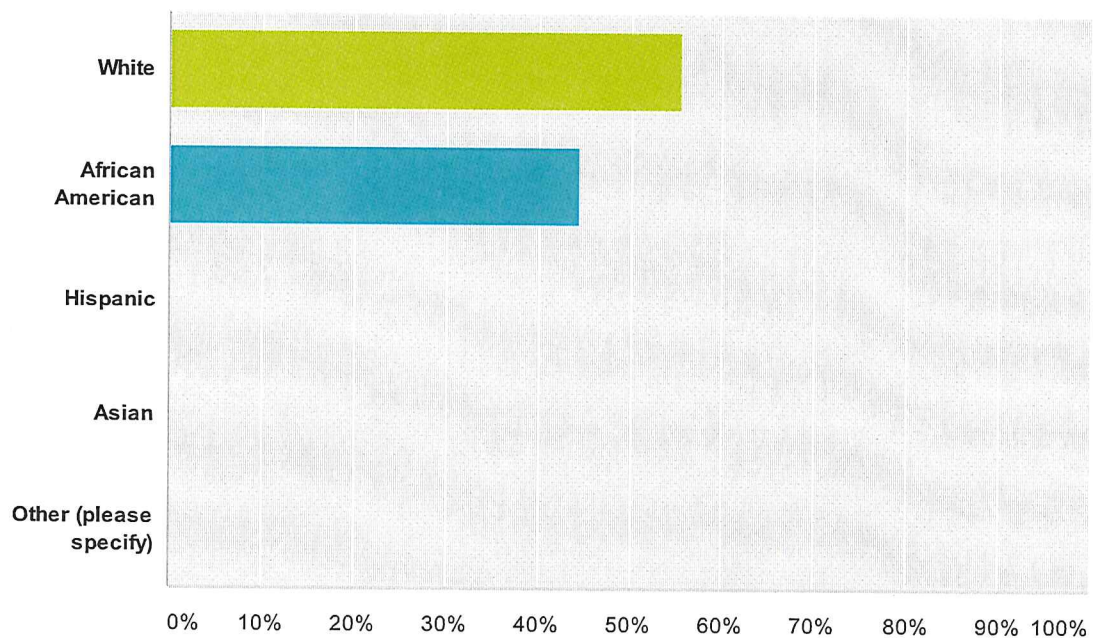

Q3 What is your race/ethnicity

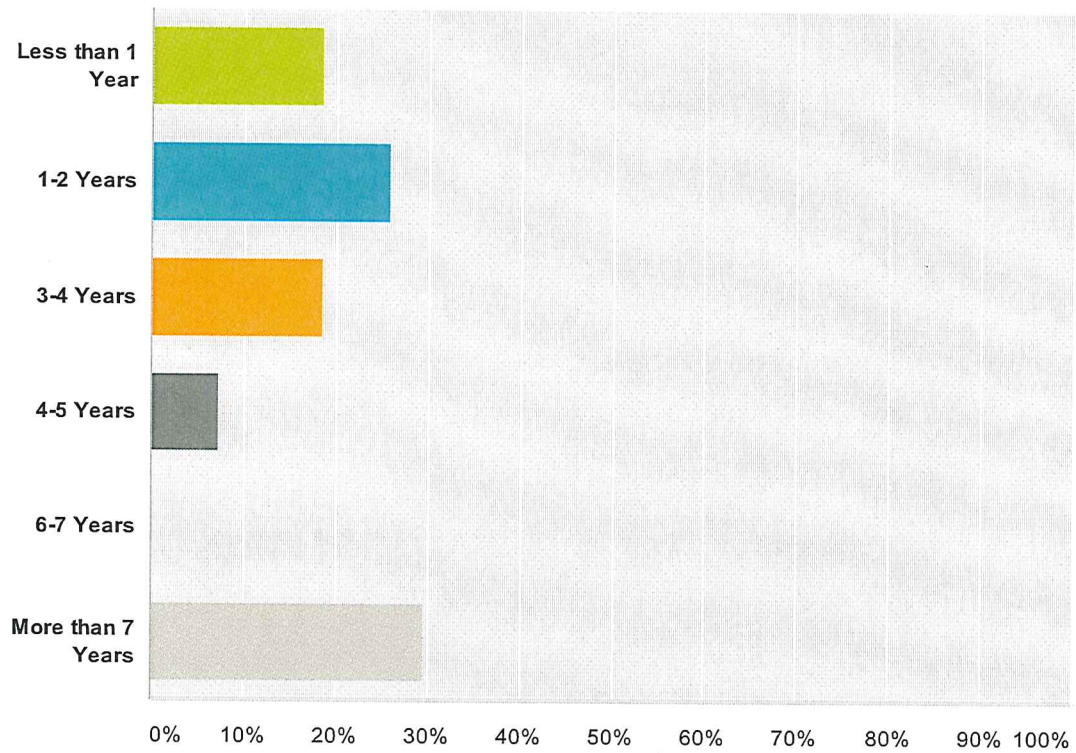

Q4 How long have you been a Foster Parent?

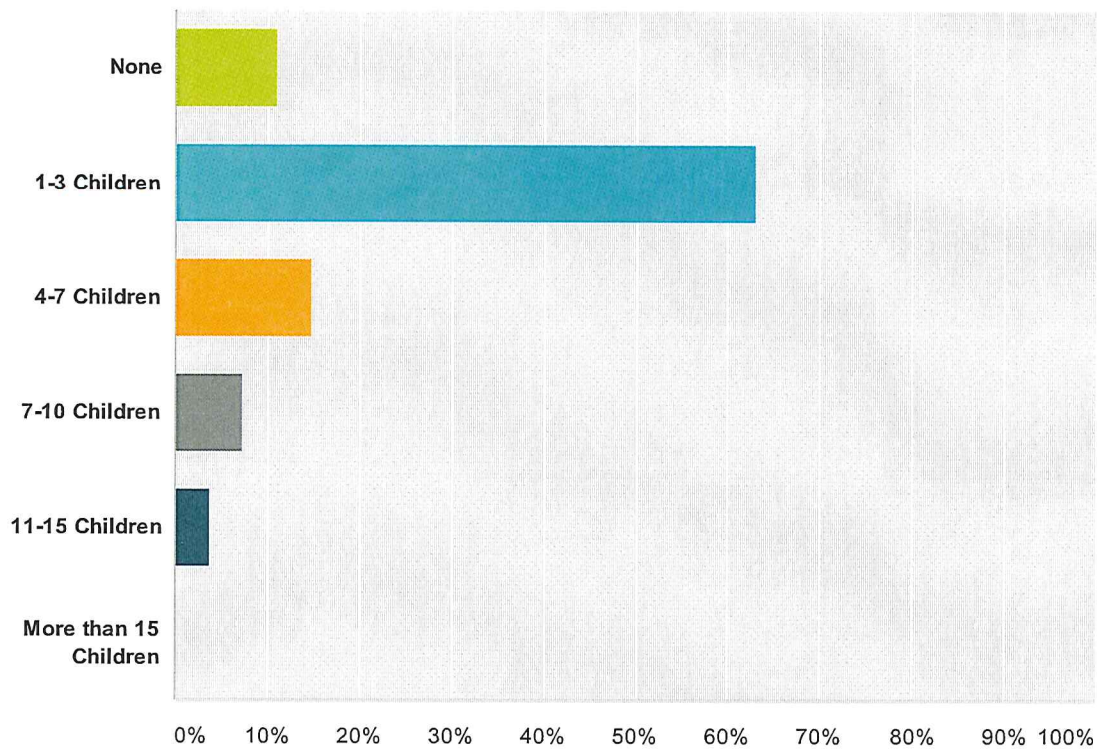

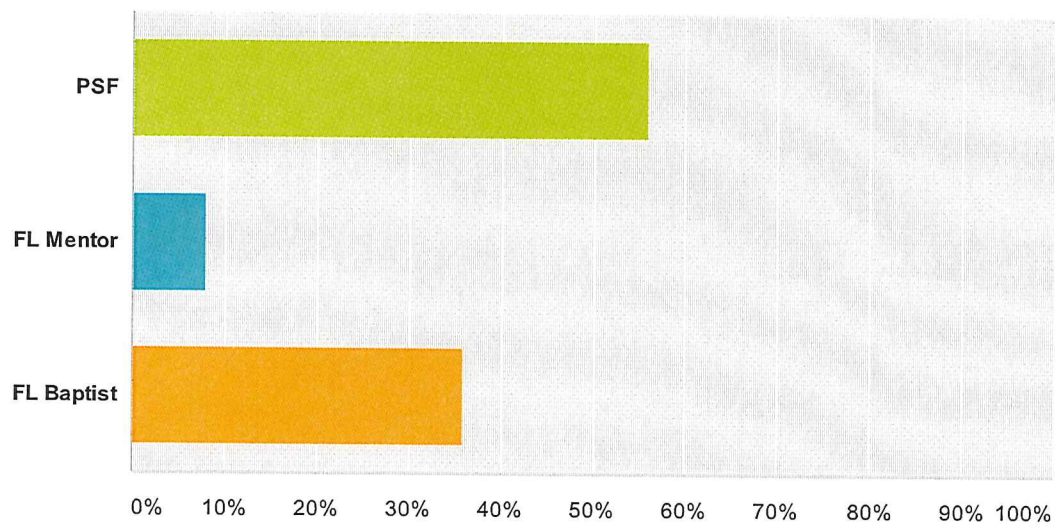

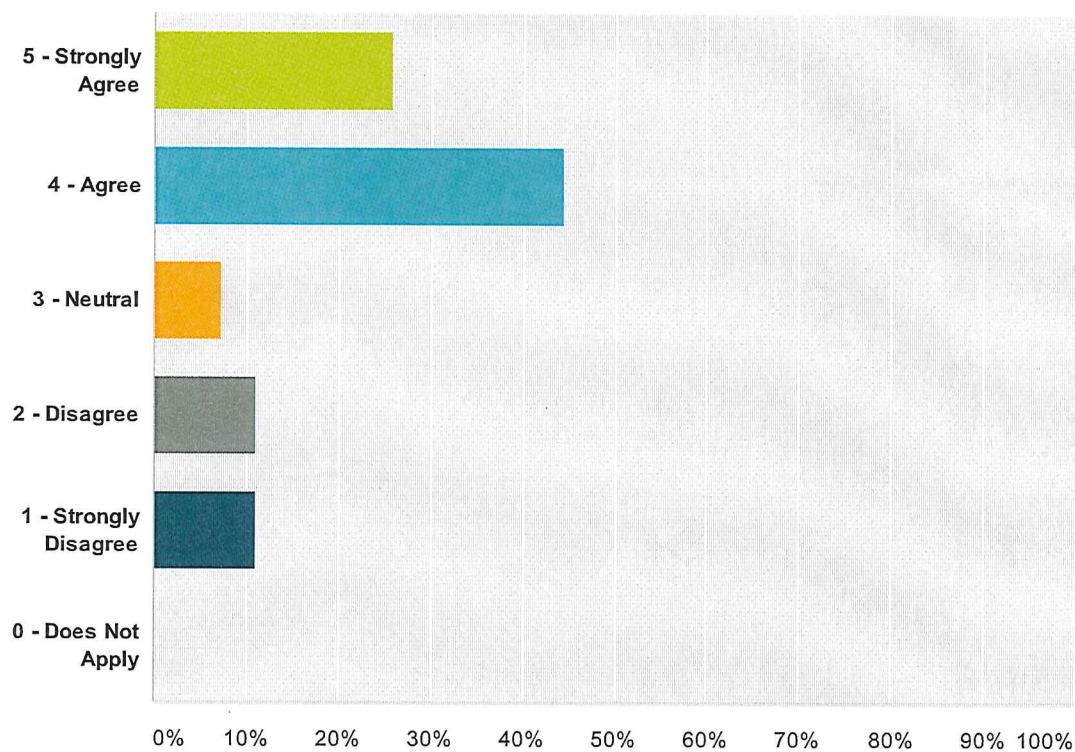

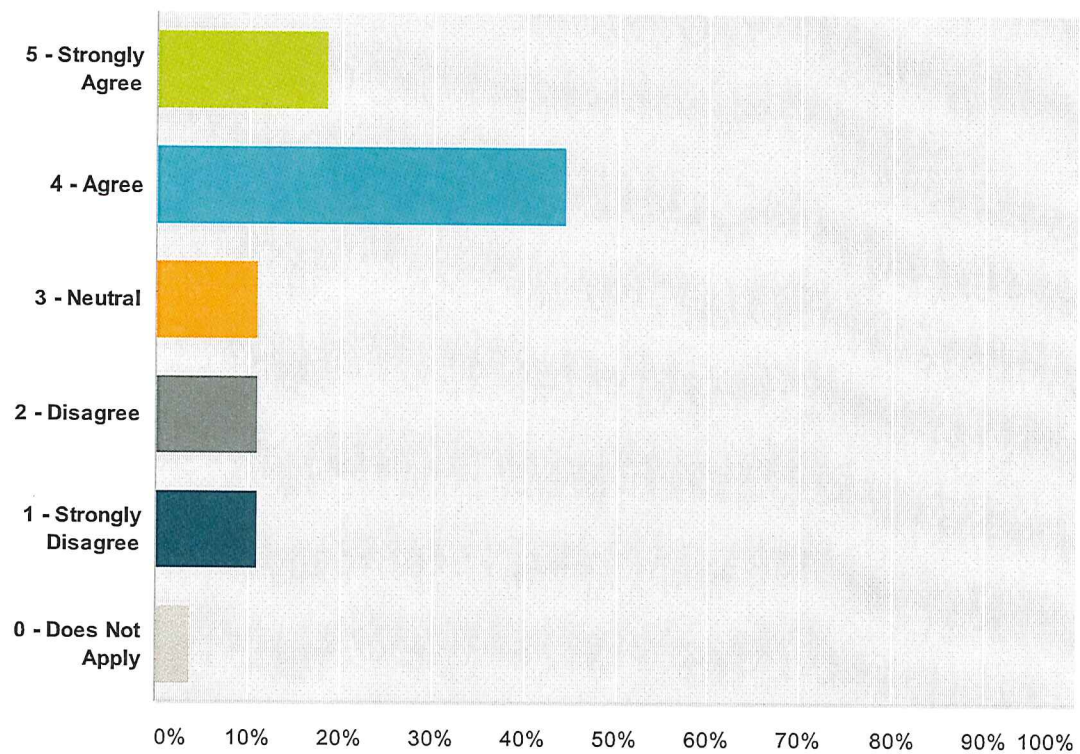

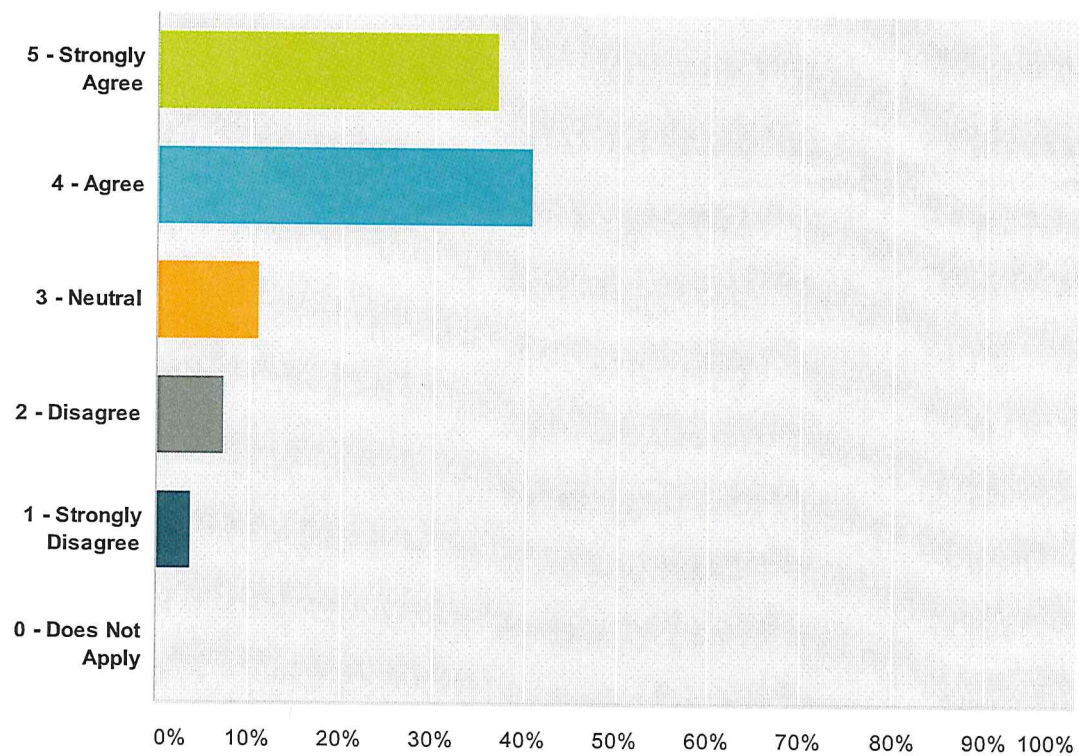

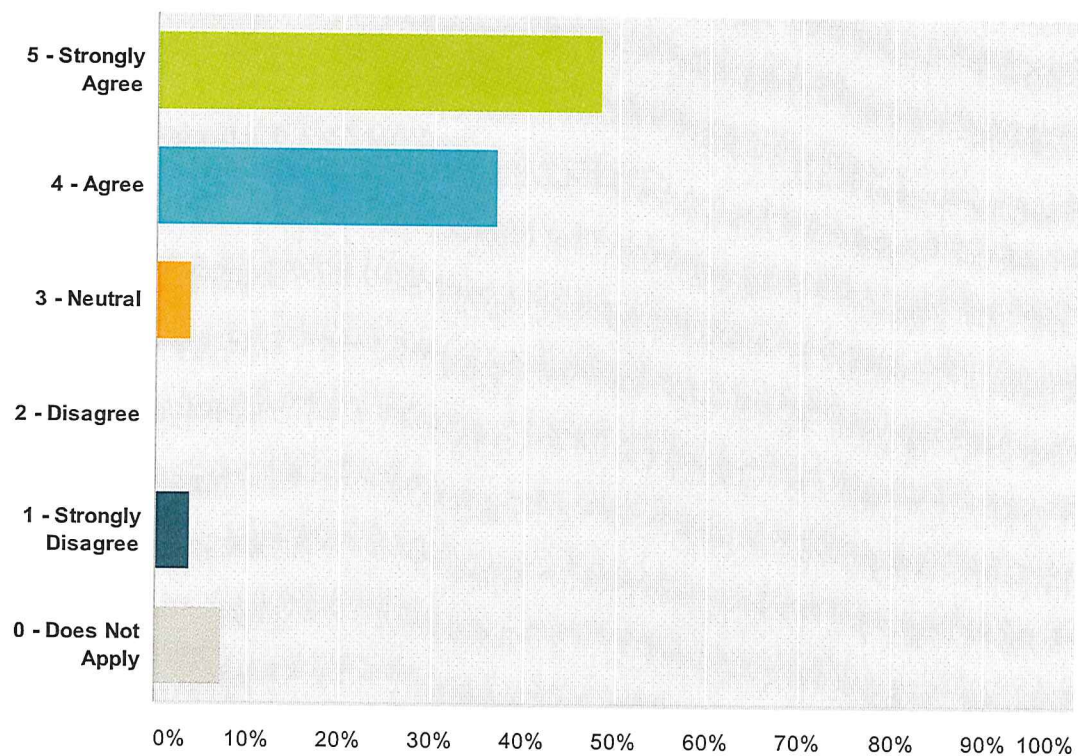

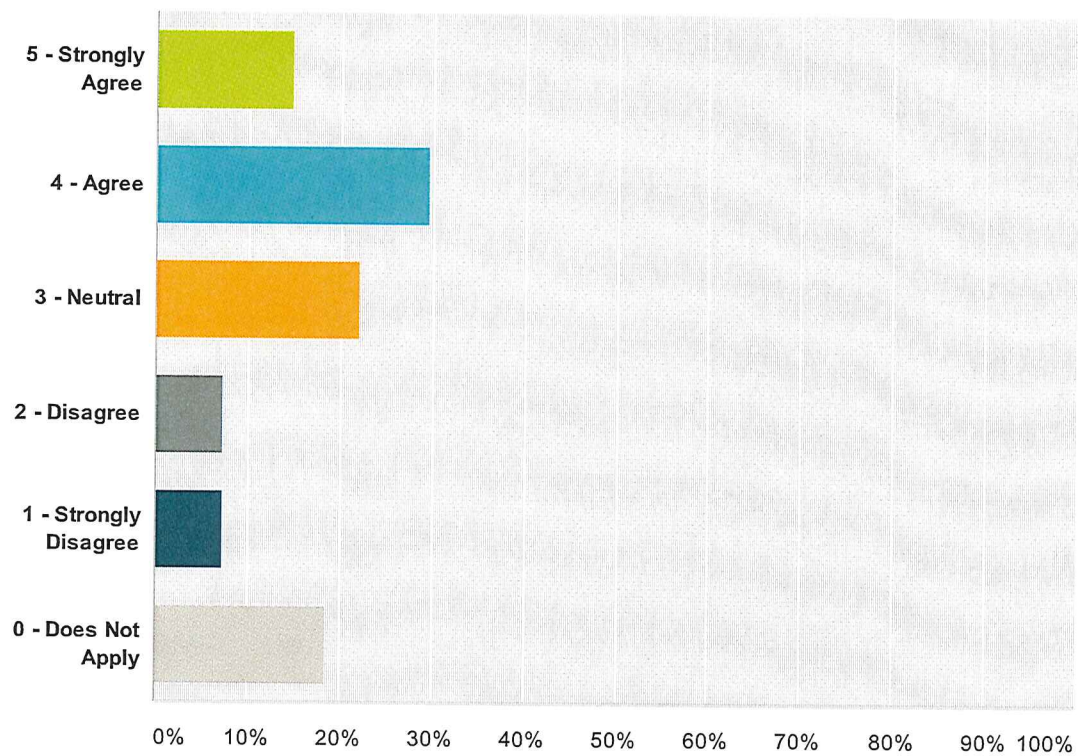

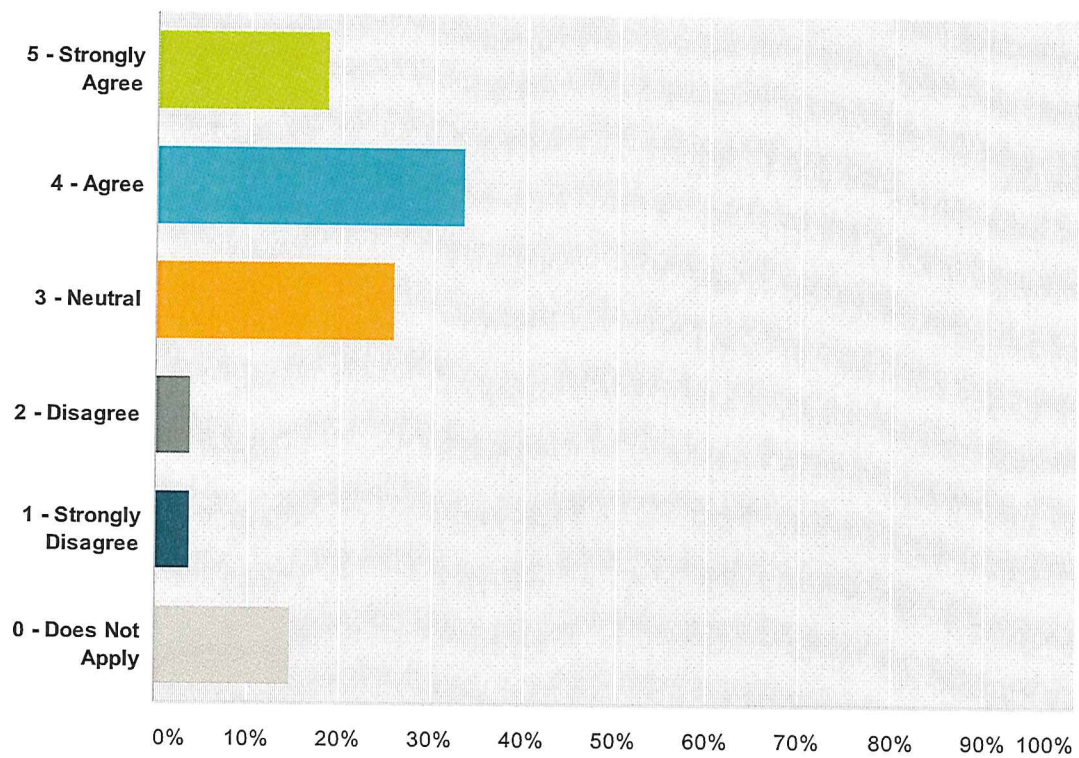

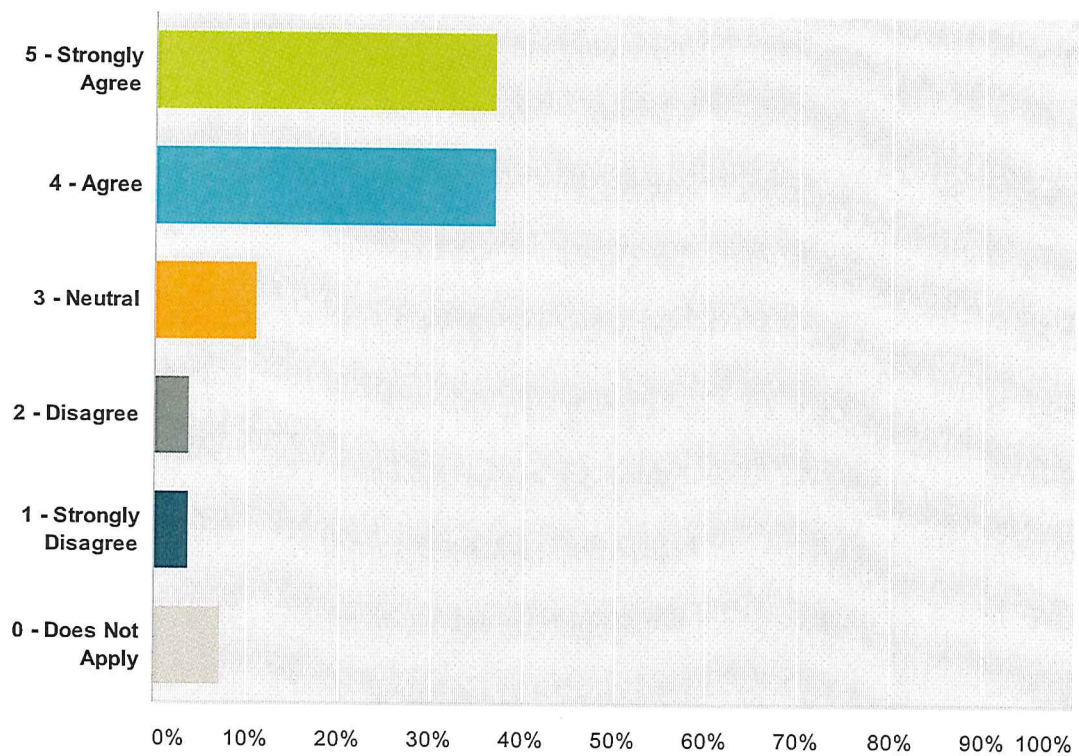

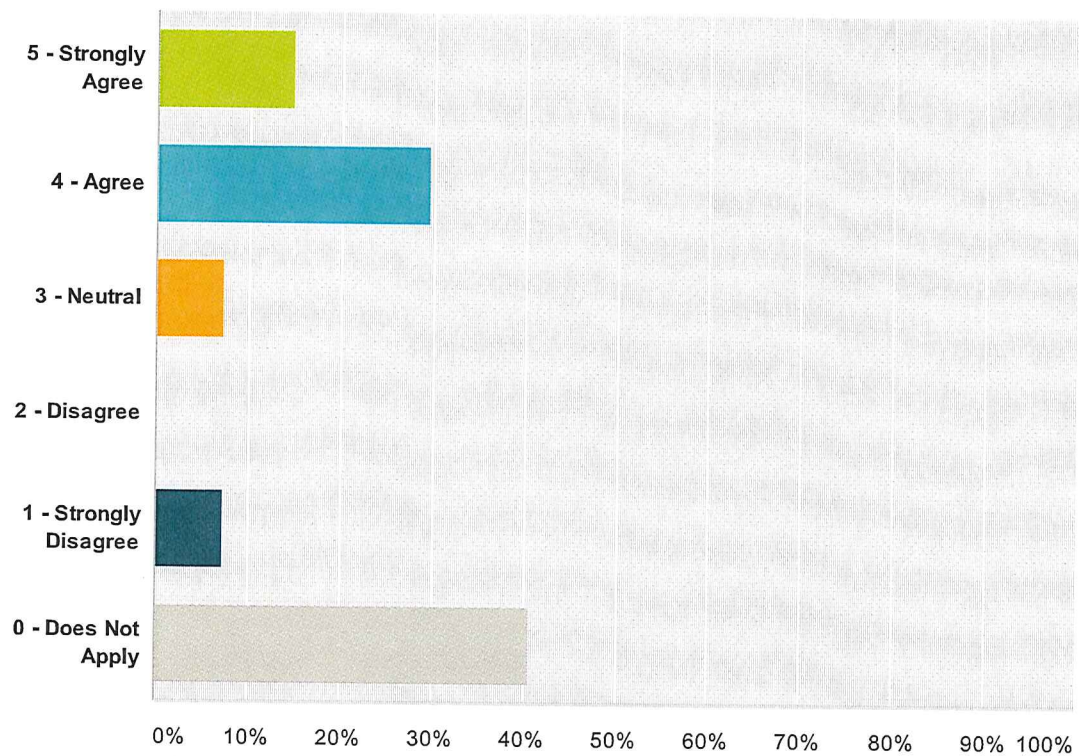
