#### MEDICAID BENEFITS

During these trying times, Sunshine Healthcare offers additional benefits to families on the Child Welfare plan. These benefits include the \$25 over the counter medications available every month as well as the \$150 yearly Care Grant for therapeutic items not covered by Medicaid (for example, sports registration fees). #### JUST A REMINDER

- Subsidy benefits are processed on the 5<sup>th</sup> of the month, payments are generated after that date.
- Adoption subsidy and Medicaid end when the child turns 18 (unless the child is in the EMAS program), regardless of if they are still in high school.
- Subsidy benefits also end in the unlikely event of the child passing away, or if the
  adoptive parent(s) pass away. Subsidy benefits are not transferrable to alternate
  caregivers.
