

#### Trust Based Relational Intervention Training



Trust-Based Relational Intervention® (TBRI) is an attachment-based, trauma-informed intervention that is designed to meet the complex needs of vulnerable children. TBRI® uses Empowering Principles to address physical needs, Connecting Principles for attachment needs, and Correcting

Principles to disarm fear-based behaviors. Beginning the first week of June, PSF will offer weekly TBRI® Caregiver training classes on Tuesdays 9 a.m. - 12 p.m. and Thursdays 6 p.m. - 9 p.m. Trainings will run for four consecutive weeks. #### Refer a Friend

Do you know someone interested in becoming a foster parent? Please have them email <a href="Moneoperatric"><u>HopePartner@pfsf.org</u></a> and ask them to let the Recruitment Team know you referred them. Partner Families can receive a referral incentive of \$125 when your referral becomes licensed and accepts placement.



The Caregiver Support Team are the connection for Partner Families in need of assistance navigating the child welfare system. Your Caregiver Support Specialist can answer general questions, help connect you to specific departments or people to assist you, and connect you with the Case Management staff for case specific questions. The team can assist with things like referrals for childcare, accessing various funding sources for specific needs your foster children may have and help you access Child Resource Record documents. Additionally, your Caregiver Support Specialist can connect you with access to training needed for the annual re-licensing requirements as they will serve as your point of contact for all annual relicensing activities. #### Travel Reimbursement

Licensed foster parents (Levels 2-5) are eligible to receive travel reimbursement for providing transportation for children placed in their care. Reimbursable categories include transportation for visitation with parents and siblings, medical and mental health appointments, vocational training programs, attendance to court proceedings and staffings, and participation of in-service trainings. Travel reimbursement requests should be submitted to your Caregiver Support Specialist monthly. To learn more, contact your Caregiver Support Specialist.

#### UNDERSTANDING THE ORGANIZATION

Partnership for Strong Families is the Lead Community Based Care agency serving North Central Florida. PSF contracts with the Department of Children and Families (DCF) to provide foster care, adoption and related services for Alachua, Baker, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison, Suwannee, Taylor, and Union Counties.

PSF provides Foster Home licensing, Placement, and Adoption Services in house. Case Management services are provided
