RESOURCE CENTERS AWARDED FIVE YEAR FEDERAL GRANT By Deborah Rubin, Community Relations Assistant

We have very exciting news here at Partnership for Strong Families! Our Resource Centers were awarded a five-year federal grant from the Children's Bureau within the U.S. Department of Health and Human Services' Administration on Children, Youth and Families to evaluate our current Resource Center Model and eventually expand the model to Lake City. The overall goal of the *Community Collaborations to Strengthen and Preserve Families* grant is to prevent child maltreatment and reduce entries into foster care.

The Administration for Children and Families will provide over \$2.7 million in funding over the five years. During this time, services provided at our Resource Centers will undergo a rigorous evaluation. After the evaluation, these findings will be used to refine our model as we work toward expansion.

In December, our staff traveled to Washington D.C. for the Community Collaborations to Strengthen and Preserve Families Kick-off meeting with our grant evaluator Dr. Robin Perry. In January, we also held our first Resource Center Advisory Committee Meeting in Lake City to begin the process of developing a new Resource Center. We met with over 30 community members of Lake City to collaborate on the future Resource Center and what would best benefit the community there. We are so excited for the opportunity to expand our mission to prevent child abuse in Lake City.

I am also eager to finalize our agency's Strategic Plan and Action Plan that will chart our course for the next three years and beyond. Our staff and Board have worked diligently to ensure these plans are responsive to the needs and strengths of our agency. Among some of our key priorities, we will be working to enhance the satisfaction of our staff and partners, starting with an employee satisfaction survey that will help to identify ways we can better support our work family - a family that continues to grow with new opportunities.

In 2019, new staff members joined our team as we expanded our licensing unit to incorporate new Level 1 licenses for our Kin Caregivers. This program allows for enhanced support for our relative and fictive kin caregivers, increasing their monthly subsidy and allowing for more training opportunities that will help to better equip them to serve the children in their care. Our staff is also growing thanks to the new federal grant that will allow us to evaluate and expand our Resource Center Model. We are currently identifying candidates to serve as research coordinators and to staff the new Resource Center that will open in Lake City in early 2021.

I wish you all a happy and productive start to this new decade.

EDUCATION ADVOCACY PROGRAM

In 2019, PSF was awarded a grant from the United Way of North Central Florida to implement a new Education Advocacy program with the goal of better supporting the educational needs of youth in out-of-home care. The target population served by the grant is youth in high school residing within Alachua, Dixie, Gilchrist and Levy Counties. Recently, the program has been expanded to include youth in middle school and also those residing in Bradford and Union Counties.

Teens enrolled in the program have been working hard to set goals, identify action steps, and plan self-advocacy strategies if they need additional supports. Most recently the program has been working on breaking down the digital divide to ensure students have access to electronic devices for educational purposes. Nationally, 17% of high school students are not able to complete homework assignments due to lack of internet service. A recent study reports and highlights the need to connect students to eliminate the information gap. When teens are connected to supervised digital resources, they can frequently check their grades, access a plethora of study materials, and advance in their studies through online classes. Technology can be such an important tool in the distribution of information and advancement opportunities!

Another program success has been the connection of youth to local academic resources. There are many tutoring resources available for teens throughout our region, although finding the right fit can be a hurdle. Schools and afterschool programs have an abundance of resources with teachers who are willing to stay for an extended day to ensure student success. Local tutoring centers, such as Mathnasium, also offer intensive supports to our youth who could benefit from focusing on misconceptions and concept mastery. By being connected to these local academic resources, it is our goal that all students graduate from high school and move on to college or career readiness.

A recent highlight of the Education Advocate has been observing the four-month progression of goals in a student, as well as the subsequent growth that has occurred. From setting academic goals to uncovering content misconceptions, to motivational goals regarding the completion of homework, and now process oriented goals to turn that (correct and completed) homework in; this teen is learning to break large tasks into smaller, actionable steps to see progress and grow in critical thinking and problem solving skills. The Education Advocacy Program continues to grow and assist teens, such as this student, to break down barriers to success in education and encourage youth in their academic goals.
