The Newton Family Adoption Story:

Adopting teenagers is challenging but so worth it! On November 19, 2020, our family of 5 grew to a family of 7 when our 15-year-old twin girls moved in. Together, we decided to invite them into our family after we found out about the abuse that they were experiencing.

Our girls may look identical on the outside but are two very different and unique people with different dreams. One desired a mom, dad, and siblings and one desired a safe place to find her independence. Today, I can tell you that both dreams are valid, I can also tell you that our family had to learn to accept and embrace both of their hearts' desires even if it differed from ours.

Of course, my husband and I hoped both girls would want us to be their parents, but, we had to learn and accept and respect both choices. Both of our girl's stories are beautiful and both have brought joy and strength to our family and our community.

On our adoption day, one took our last name, one did not.

PROGRAM HIGHLIGHT: HELP ME GROW

We are honored to partner with the Children's Trust of Alachua County to bring the Help Me Grow Program to Alachua County. Help Me Grow is a national initiative dedicated to supporting healthy child development for children birth to eight. The program is offered locally at both PSF Family Resource Centers in Gainesville, Library Partnership and SWAG. In addition, staff are doing outreach throughout all of Alachua County. Through our two Help Me Grow Coordinators, families are connected with educational programs and therapeutic services that empower parents and caregivers to help their children reach their individual full potential.

We recently sat down with the parents and had the wonderful opportunity to speak with Ebony and Travis, parents of Taevin, the most precious six-year-old. Ebony and Travis have been working closely with our Help Me Grow Coordinator, Katrina, to access resources that will support their young son.



Ebony first began noticing concerns when Taevin was nine months old. "He would master things and then, after a while, he would lose them," she recalled. "I was thinking, 'This isn't normal.'" For years, Ebony brought up her concerns with Taevin's pediatrician, with little support or insight provided due to their busy schedules.

This past spring, Ebony was introduced to the newly launched program. Ebony quickly completed the online screening and was connected to Katrina. In addition to getting to know Ebony and Taevin, Katrina conducted additional screenings with Taevin while Ebony completed two developmental questionnaires. "When the results came back, it gave me confirmation that we needed to move forward in getting a formal diagnosis," Ebony shared.

Katrina supported Ebony and Travis with finding the right resources and next steps to address their son's developmental needs. "It can be overwhelming at times when you're trying to navigate all of this as a parent," Ebony said, "but Help Me Grow gives you a sense of empowerment. It gives you a sense of hope, like you've got somebody who is backing you."

Through early intervention, personalized support, and strong community partnerships, Help Me Grow continues to make a meaningful difference in the lives of local families by ensuring every child can thrive.

I knew she was ours and we were hers.



BACK-TO-SCHOOL UPDATE

A Strong Start for All Students! By Brianna Peterson

Thanks to our incredible community, we were able to support 462 youth in out-of-home care during this year's Back-to-School Drive! Seven sponsors, fourteen individual donors, eighteen donation bin partners, and twenty-two volunteers helped to ensure each student in care has a backpack filled with tools they need for the upcoming school year.

We also organized two Back-to-School events in the community to support students in under-served areas. In Lake City, our NorthStar Family Resource Center partnered with Community Barbers of Lake City to provide 743 students with free haircuts and school supplies, along with 500 backpacks donated by the local Wal-Mart. For the event's 10th anniversary, over 40 community partners gathered to support families and prepare local youth for the coming school year.

In Fort White, the PSF-led Children's Partnership Council (CPC) of Columbia County coordinated an event and resource fair at Fort White High School. 18 local agencies served over 300 students with free supplies. Families appreciated learning about support in their area. We enjoyed the sense of fellowship and empowerment that was shared during these wonderful events!

Legal Permanence: A Brief and Partial History By Kelsey Burnett

In 1997, Congress passed the Adoption and Safe Families Act (ASFA). 1997 also happens to be the year I graduated from law school and discovered the child welfare system. I was the new kid on the block in a small prosecuting attorney's office in West Virginia, and I was tasked with handling civil child abuse and neglect cases (what in Florida we call dependency cases) on behalf of our local Department of Health and Human Resources (the equivalent of Florida's Department of Children and Families).

I was nervous and excited, as newly minted baby lawyers tend to be, and fortunately for me, one of the first things that happened was a training on the new federal law, ASFA, and the corresponding changes to WV's state statutes. ASFA refocused federal child welfare law on child safety and timely permanence for youth in foster care, as well as on encouraging adoption, and like West Virginia, the other 49 states made changes to their laws and policies consistent with ASFA.

Florida law is detailed in its approach. It includes specific possible permanency outcomes. The top three, in order of preference, are Reunification, Adoption, and Permanent Guardianship. FL law also provides that permanency should occur in the shortest time possible but no later than one year from removal or adjudication of dependency. There was concern that too many children were lingering in foster care without permanence, and the laws were designed to address that concern.

If you read my articles, please remember this, as in my next article, I plan to talk about Permanent Guardianship specifically. Although the court is required by law to retain jurisdiction of cases that close in Permanent Guardianship, allowing for the possibility of reopening and modifying its order, Permanent Guardianship is meant to be permanent. In my next article, I will delve into what this means and how it plays out in real life.
